


Survey Conducted November 2013 Summary by Mike Conger



Mostly consultants responded (32) followed by Local Government (11)


Q2 How many TSITE Quarterly meetings (Winter, Spring, Summer, Fall) have you attended in the past 2 years?





Fairly even distribution


Q3 How would you rate the Quarterly Meetings you have attended for the following:



Answered: 50 Skipped: 4


Q4 How would you rate the length of the Quarterly Meetings?

Answered: 54 Skipped: 0




Q5 If you have NOT attended a recent Quarterly Meeting, please check the reasons why

Q6 Which of the following actions should TSITE take to encourage more meeting participation?



"Other" Responses for Question 6 – How to encourage more meeting participation


- Reduce/subsidize registration costs

Q8 If you selected picking a consistent location in the previous response, please list your first preference of the following locations:




Smokies Tourist Area received 17/26 votes, but from previous question it appears most still prefer to rotate mtgs

Q9 – List any specific ideas/recommendations you have for ways to improve the Summer Meeting


- Provide an activity for members to participate.




- Activity) Information about Knoxville chapter seems need an update.

Q12 – Are there any features or information that you would like to see added or changed on the TSITE website?






- Take some the hot topics that International is addressing and include links to their reports on the website.
